A REPORT OF THE GENERAL BODY MEETING ON MS TEAMS PLATFORM

Date: 09-Feb-2025

Time: 4:30 pm

The number of life members as on date was 103. In view of quorum not being present at the appointed time, the President decided to adjourn the meeting and reconvene it **at 4:30 pm**. The agenda for the General Body meet was as follows:

1. Welcome address by the President of the Samaj
2. Secretary's Report presented by the Joint Secretary
3. Statement of Accounts from 1st April 2024 to 31st December 2024 presented by the Treasurer
4. Announcement of elections to the new executive committee by the President
5. Appointment of Returning officer for the elections
6. Open Session for general interaction between the members present
7. Vote of Thanks given by the Vice President

The President formally opened the meeting and welcomed the members present. Screenshots of the members present during the meeting are placed at **Annexure 1** below.

The President stated that the Covid situation prevailing when the new executive body took over provided an opportunity for this new option of conducting general body and executive committee meeting in an online mode. This allowed more frequent meetings compared to earlier. He further stated that the elections to a new executive body are being advanced by a few months, so that the new executive body could commence its operations from start of the financial year itself.

The Joint Secretary, Mr. KGK Patro, thereafter read the three year Secretary's Report on the accomplishments of the Samaj from February 2022 to January 2025. This report is placed with these minutes at **Annexure 2**.

Thereafter, the Treasurer, Shri Ashok Boyina, provided a gist of financial position of the Samaj. He stated that the Samaj was holding approximately a balance of around 4 lakhs which has now increased to Rs 6 lakh 83 thousand i.e an increase of more than 50%, in spite of numerous activities that have been performed and conducted during the last 5 years. This position is as a result of generous and substantial sponsorships from our life members for various events conducted offline and also due to conducting many meetings online. The statement of accounts of the Samaj from 1st April 2024 till 31st December 2024 is placed at **Annexure 3**.

The President then formally announced that the next election for the executive committee will be conducted in March 2025, so that the new body starts functioning from April 2025 onwards.

The next point on the agenda was appointment of Returning officer for conducting the above elections. The President informed that the executive committee had decided to entrust the responsibility to Dr. GP Rao, who had earlier conducted smooth elections in 2020. Among the members present, Dr. Ganesh Prusty and Mr. Ramprasad Patro suggested that Dr. GP Rao should reconsider his acceptance of being the Returning Officer, as he is a very suitable candidate to take up the position of President. However, Dr. GP Rao stated that he would be more comfortable in an advisory role rather than taking up an executive post.



Accordingly, the President announced that Dr. GP Rao will continue to be the Returning officer as decided by the Executive Committee and confirmed by the General Body. The President communicated that the election process will have option for self-nomination. Also on a query from Mr. KGK Patro, Dr. GP Rao informed that a scanned copy of signed nomination form can be sent by whatsapp to him as the Returning Officer.

Vice President, Dr. Ganesh Prusty, presented his vote of thanks. This being the last General Body Meeting of this tenure, he most graciously lauded the performance of the Executive Committee for the past five years. He individually thanked each of the Executive Committee members. In addition, he also thanked other members who participated in the meeting including Mr. Kota Srinivas Sekhar Choudhury, Mr. Praveen Subudhi and Mr. Korada Ananda Rao.

The Jt. Secretary Mr. KGK Patro thanked his elder brother Mr. K Anand Rao who was hosting him at Chennai at the moment and who also provided the necessary wi fi services to him.

**Kalinga Vysya Samaj New Delhi NCR
Secretary Report of Accomplishments in the last 3 years
(February 2022 to January 2025)**

- You would all be glad to know that our life membership has gone up from 78 in October 2020 (when this new body took over) to the present strength of 103. Our membership drive continues and we hope to cross higher levels with active co-operation from our existing life members.
- You would all be aware that with a lot of efforts by the executive committee, the samaj was granted 80G benefits on a provisional basis for three financial years from 28 March 2022. This had come almost 25 years after the Samaj was formed in 1995. However this was for a limited period upto 31st March 2024. A number of our members made considerable amounts of contributions and availed special benefits under section 80G of Income tax act. Ours being a cultural cum charitable organisation, we continue our efforts to extend our quest for 80G benefits by applying afresh through our CA.
- Our Kalinga Vysya Samaj has now Darpan registration with Unique id No. DL/2023/0370092 in March 2024 with Registrar of Societies. Darpan registered NGOs are eligible to apply for grants and funding opportunities offered by various ministries and government agencies. This access to government grants can significantly enhance the financial sustainability of the NGO and support the implementation of its projects and programs.
- In one of the executive meetings, it was decided to create an app for Kalinga Vysya Samaj to foster closer relations and information dissemination. I hope, you all would have liked the app, which has been unveiled a few months ago.
- In the year 2022 we had two webinars and one physical gathering.
 - Under the title “Career Opportunities Series - 3” a webinar was organized 13-02-2022 which addressed opportunities in stocks and mutual funds sector. The President formally opened the web meet. The panelists were Mr. Ravi Kumar Korada, (Director - Meliora Asset Reconstruction Company Ltd, Visakhapatnam) and Mr. N Mrutyunjaya Rao (Financial Advisor, AMFI Certified Mutual Fund Distributor, Visakhapatnam). Dr. GP Rao was the session co-ordinator. After the welcome address by the President, Dr. GP Rao introduced the moderator, Dr. Sanjukta Subudhi to the audience, who then introduced the two panelists. The two speakers made power point presentations. The session lasted for about forty minutes and then it was followed by fielding of various questions from the audience. Dr Sanjukta Subudhi then summarized the session and also presented her own slide detailing out eligibility criteria for persons seeking this line of career.
 - Under the title “Career Opportunities Series – Event 4” another webinar was organized on 26-06-2022 which addressed opportunities in hospitality sector (Hotel, Travel etc.). The President formally opened the web meet. The speaker was Mr. Sheshadri Vaddi, HR Division, Trident Hotel, Hyderabad). Dr. GP Rao was the session co-ordinator and Mrs Kanya K Patra, Finance and HR Divn. of SPG Consulting & Solution Services, was the moderator. The session started after the welcome address by the President, Shri Kotni Srinivas. After the presentation, there was a short Q&A session during which the President also shared his personal experience and explained the usefulness of this lucrative career in hospitality sector. Ms Saloni who has made a name in the i-tunes chart with her superlative performances, enthralled the audience with her songs in Telugu, Odia and Hindi. One of the songs was interestingly multilingual – a mix of 10 languages.

- The Kartik Vanabhojanam physical General body meet of the Samaj was organized on Sunday 30th October 2022 falling in the common fortnight of Kartik month of both Odisha and Andhra. The venue selected was the Park near Sector 3, RK Puram, New Delhi, being centrally located. After the introductions by the participants, Vasavi Puja was conducted, in which the ladies participated whole heartedly. Mrs. Uma Prusty and Mrs Prashanti sang bhajans commensurate with the occasion. This was followed by buffet lunch at the venue. About 70 persons (adults and children) had gathered that day. Due to paucity of time, post lunch events included only Tambola and a mini quiz show involving punch lines of marketing brands, conducted by Mr. Ramprasad Patro.
- In the year 2023 we had five webinars and one physical gathering.
 - The first webinar was held on 26th March 2023 to celebrate Rama Navami and Ugadi, during which competitions on audio, video and rangoli were held. Amazon gift vouchers of Rs. 2000 and Rs. 1000 to all 1st and 2nd prize holders. Further, all other entries received “Certificate of Appreciation”, and received Amazon gift vouchers of Rs. 250 each.
 - The next webinar conducted on Sunday, 23-04-2023 was on organ donations by Dr. B Saroj K Prusty, Senior Consultant and HOD Critical Care Medicine, at Virinchi Hospitals, Hyderabad.
 - The third webinar, held after the International Yoga day, on 25th June 2023 focussed on Yoga by Mrs. Jammula Lalita, Yoga Teacher from Yoga Sadhana group from Brahmapur, Odisha.
 - Recognizing the importance of environment in the present day world, the fourth webinar was held on 20th August 2023 by the Samaj. The talk was presented by Dr. Sundara Narayana Patro, M.Sc, Ph D in Botany, President, Orissa Environment Society.
 - As is the general practice, an outdoor picnic, namely, Kartik Vanabhojanam, was held on 19th November 2023 at Sector 17 park in Dwarka. After the Vasavi puja in the morning, Mrs Prashanti & Mrs. Sangeeta Rani Patra sang bhajans commensurate with the occasion. In a first of its kind, children were asked to introduce their parents. On this occasion, Late Dr. K S N Subudhi, Past Secretary and President, was awarded with Gaurav Award posthumously. The citation was read out by the President, Mr. Kotni Srinivas. The award was received by Mrs. Draupadi Subudhi on his behalf. However, the picnic was cut short at 3:30 pm in the afternoon in view of India’s T20 world cup cricket final match in the evening.
- In the year 2024 we had two webinars and two physical gatherings. Further, we also celebrated Vasavi Kanyaka Parameswari Puja during Durga Puja Navaratri days.
 - A webinar was conducted on 7th April 2024, focussing on career growth opportunities in legal domain for our children. Ms Andavarapu Rohini, Junior Civil Judge at Bobbili was the principal speaker. She was supported by two other speakers, Mrs. Raj Latha Kotni and Mr. Baratam Amarnath. Our President, Mr. Srinivas Kotni was the host and moderator for the webinar. A recording of the webinar has been circulated in our whatsapp group.
 - A General Body Meeting with physical gathering of the Samaj Members took place on Sunday, 21-04-24 at Jagannath Mandir, Hauz Khas. The meeting started with a bhajan by Smt K Prashanti. After the initial introductions, the President announced the unveiling of a new mobile app for our samaj, namely, ‘Kalinga Vysya Samaj’, developed for android devices by Javin Global. It was followed by a detailed presentation of the app by the Secretary, Sri Ramprasad, by

projecting its video. (This mobile has since been upgraded in December 2024 to cater to Apple devices as well.) Everyone had a sumptuous Mahaprasad dinner after the meeting.

- To commemorate the foundation day of the Samaj, a webinar was organized on 7th July 2024, the Rath Yatra day. Mrs. Kanya Patra took the stage and compered the foundation day celebrations. After the invocation songs, an audio recording of Vaasavi Maa was played out. After this, goodwill audio and video messages by eminent members of the Samaj were played out.

A slide showing the nine founder members was shown with a brief introduction by the President. The next slide presented the seven Patron members each of whom had made a donation of Rs. 15,000 in one go. The next three slides presented all the 95 life members of the Samaj

Next came an entertaining art work video by 8 year old Miss Kruti Boyina,. This was followed by a dance video by Master Sarthak. An entertaining recorded video of a fusion dance having artistes from all the seven classical dance forms of India was shown next. Then followed a recorded video of Bharatanatyam dance by Ms. Abhilasha. Then came another recorded video of a bollywood dance by Ms. Mounika, daughter of Shri Satish Kalivarapu.

- Karthik Vana Bhojanam (picnic) of the Samaj was organised this year on Sunday, the 1st December 2024 at Nehru Park of NDMC in Chanakyapuri, starting at 11 am. For the first time the Samaj had such a large gathering. With around 30 families participating, the head count (including children) was around 80. After the assembly of guests, Vaasavi puja was conducted by Prashanti Ma'am with active participation of many lady members. Before and after the puja delicious snacks including hot pakodas and bhajjis with hot tea were arranged for everyone. After a delicious lunch, a game of Tambola (free tickets) was played, conducted by Ms Sweetie, Mrs. Roja Subudhi, and Kanya Patra. Winners were presented with gifts instead of cash prizes. As a last item of the day, surprise lucky draw gifts were presented to many members over tea and snacks, with the condition that Tambola winners were to be excluded from this lucky draw to maximize gift receiving.

A General Body meeting of the Samaj was held in the premises of Sri Jagannath Temple, Hauz Khas, Delhi.

The agenda for the meeting was :

- a) Announcement of election results by election officer Sri G. P. Rao;
 - b) Acceptance address by elected President;
 - c) Introduction of new team members of executive Committee/Governing body;
 - d) Co-opting of additional executive committee members;
1. Sri G P Rao as election officer announced the election results of new Executive Committee members as follows:

e) Distribution of Responsibilities:

Responsibilities will be allocated among Executive Committee meetings to ensure smooth functioning and effective implementation of society initiatives.

f) Member Support Mechanism:

All members are encouraged to freely communicate their issues or seek assistance of any nature. The Samaj will strive to offer necessary support within its capacity.

g) Group Communication Protocol:

Only messages strictly related to Samaj development activities, Birthday wishes, and Anniversary greetings are permitted in the Kalinga Vysya Samaj 25 -30 whatsapp group. Members are requested to refrain from unrelated postings. If they want to post they should get approval from the Elected body.

h) Additional Suggestions and Points:

Suggestions from members for betterment of the Samaj are always welcome and will be considered in future meetings.

4. The members thanked the President for his vision towards the Samaj and congratulated the team members for the new innings and wished that Samaj would continue to do noble works towards the betterment of our community.

Members also thanked the President for all the arrangements for the meeting at Sri Jagannath Mandir and sponsoring the mahaprashad for all.

5. The Out going President, Sri Kotni Srinivas was magnanimous enough to announce that he would contribute Rs 1,00,001 for the welfare of the Samaj.

Mr. Binoda Patro also announced a donation of Rs. 25,000 for the welfare of the Samaj.

The Samaj gratefully acknowledges the above two donations.

This was followed by members children showcasing their dancing talents. After this everyone enjoyed Sumptuous Dinner Mahaprasadam.
